POLICY FOR PROMOTION OF RESEARCH

The research policy of the Institute aims to create and support a research culture among its Faculty Members and Students and influence them for enriching and augmenting the proficient competence.

It ensures for developing and promoting technical temper, statistical tools and research aptitudes of all learners; for comprehending the vision and mission of the Institute and for contributing to nation growth.

It extends fund and plans for facilitating participation in research and related activities and by providing the required resources and appropriate facilities.

It aims at ensuring research activities of the Institute, follow to all applicable rules and regulation as well as to the established standards and norms relating to safe and ethical conduct of research.

Scope of the Research Policy

This policy shall apply to all the researchers of the Institute and include:

- All faculty members, staff who are active in education, research, management
- All students registered with the Institute
- All Guides and External Experts associated with any of the research activities of the Institute

The research and related activities will include:

- Basic, strategic and applied research undertaken either for fulfilling the requirements of academic degrees or for solving problems through community development projects

- Scholarly activities envisioned to magnify understanding by analysis, combination and clarification of ideas and information by making use of rigorous methodologies, using various Statistical Tools and SPSS
- Information, accumulation and communication for keeping well-informed academic developments in writing of textbooks, chapters of textbooks, monographs; developing and updating curriculum
- Research Projects of students undertaken as part of the curriculum and enriching the same
- Publication, Presentation and Communication of the research outcomes and related activities

Objectives of the Research Policy

- To strengthen strategic, technical and operational planning, budgeting and control of research activities
- To create and administer a research fund for supporting and facilitating research initiatives
- To develop rules, procedures and guidelines for granting research support
- To grant study leave, sabbatical leave, duty leave, reduction in workload, etc. for faculty members undertaking research activities
- To align research activities with vision and mission of the Institute
- To guide faculty members to integrate research with the regular curriculum implementation and curriculum enrichment activities
- To inform faculty members about the research opportunities announced by different academic Institutions
- To promote interdisciplinary research
- To identify and establish linkages including MOUs for widening the scope of research opportunities and funding options
- To encourage and facilitate the publication of the research work in reputed academic journals
- To encourage and facilitate the research work through academic events such as Workshops, Seminars, Guest Lectures and Conferences
- To compile data on all the Minor and Major Research Projects and Field Work undertaken by the Faculty Members and Students
- To ensure the compliance of all researchers to the research quality assurance framework, the research code and all the applicable rules and regulations
